Membership renewal from one year to the next is tacit unless the member resigns (by registered letter with acknowledgement of receipt before 12/31 of the current year).

The membership fee following renewal remains unchanged, except where the following special conditions apply:

- Application of an inflation rate to all membership bands following a decision by the cluster's Bureau.
- Signature of a new membership form, at the request of the member or the cluster, agreement on a change of bracket.

### Loyalty benefit:

When Polymeris was created, the cluster's Board decided to introduce a loyalty benefit in the form of a 3% discount after three consecutive years of full membership, increased by 1% after each additional year. To qualify for this discount, you must be up to date with your membership fees. Therefore, if you meet these criteria, you will benefit for this year 2024.

# MANAGEMENT OF YOUR PERSONAL DATE

Polymeris is committed to ensure that the collection and processing of your data, carried out at the time of your membership, complies with the General Data Protection Regulation (RGPD) and the French Data Protection Act. - Minimization of data: we have reduced the amount of data requested depending on the case.
- Data security: Via SSL protocol and secure database management, we maintain a high level of security on the path of your data.

For visitors with privileged access to the MyPolymeris platform, you can set up your e-mail alert summarizing the latest content added to your member area. You can choose if you want to receive it or not and set its content.
